This course provides a forum for clinician-investigators in Brown University's Masters program in Clinical and Translational Research to present and receive feedback on their ongoing research. Students present grant proposals (including K awards and R-series grants) and ongoing projects.

2007-2020 Course Instructor, Measuring and Improving the Quality of Medical Care, 16-20 graduate students for 2.5 hours/week for 14 weeks.

This course focuses on the science of measuring and improving the quality of health care. Students engage in a semester-long quality improvement project with an organization in the state of Rhode Island. In recent years, students have worked with Healthcentric Advisors, the Rhode Island Medicaid program, the State Health Department, Lifespan teaching hospitals, the Providence VA, PACE Rhode Island, and Neighborhood Health Plan. Several students have continued this work as masters theses and peer-reviewed publications for scientific journals. Former students have gone on to positions in quality improvement including at Lifespan, Tufts Medical Center, State government, and HealthCentric Advisors.

2016 Co-Instructor, Health Services Research Methods I, 5 graduate students for 2.5 hours/week for 14 weeks

This course is part of the core methods sequence for all 2^{nd} year doctoral students in Health Services Research.
