UNIVERSITY TEACHING ROLES

BROWN UNIVERSITY

Educational Consultant BI 360 – Doctoring, Brown Medical School Fall Semester 2005. This new course for first year medical students was initiated in the fall semester of 2005. The program and curriculum were under construction at the time the course began, and many mid-course corrections were anticipated and occurred. My role was to address emergent situations as they occurred, recruit, organize and train adjunct faculty and 4th year students who assisted in hospital-based teaching sessions, develop evaluation materials, to assist and advise regarding training and cases for standardized patients, to provide revised materials which originated from the Medical Interviewing course, and to assist course leaders in the development and revision of curriculum plans as needed.

Director BC 101 - Doctors and Patients – Clinical Communication in Medicine, 2003-present

This new undergraduate course was piloted in Brown's summer session in 2003 and offered again in the summer of 2004. It reviews theory and research on physician-patient communication addressing topics in a variety of related behavioral science disciplines including communication sciences, health psychology, health education, and medical anthropology. This course may serve as a structured introductory experience in the clinical environment for those wishing to pursue careers in health care or public health. In addition to lectures, readings and discussions, students have opportunities to observe physicians in clinical settings and conduct pilot research about communication topics. Future offerings are planned for summer session and spring semesters rotating every other year.

Director BI 371 - Medical Interviewing, Brown Medical School, 1998-2004

Medical Interviewing was a required course for all first year medical students (65-70 per year) at Brown until 2005. This is a logistically complicated course which employs small group teaching methodologies on site in hospital settings. Voluntary faculty follow a structured curriculum and lead small group teaching sessions lasting 2 hours per week in the fall semester. Course directorship activities include: coordination with Psychiatry course co-director, faculty recruitment for 34-40 voluntary faculty positions each year, faculty development and training, faculty supervision and quality control, faculty support and intervention when needed, student support and intervention when needed, detailed syllabus development and revision annually, detailed faculty guide development and revision annually, course evaluation and continuous quality improvement, grade submission, and addenda to course performance reports. The course director also frequently leads one of the small skill-teaching groups.

Director BI 568 - Academic Medicine: Teaching Medical Interviewing, Brown Medical School, 2000-2004

This clinical elective was developed to enable fourth-year medical students to teach in the first-year medical interviewing course. Students are provided with training in teaching approaches and are paired with a skilled veteran small group teacher who mentors them on teaching issues. Seminars are offered in the evenings and consists of: 1) three pre-course seminars on the medical interviewing curriculum and related teaching skills; 2) two faculty development meetings (with the entire teaching faculty for the Medical Interviewing course); 3) twelve two-hour sessions for practical application of teaching skills and supervision by senior small group faculty; 4) 3 evening teaching seminars scheduled across the fall semester

Director BI 389 – Elective Seminars in Medical Interviewing, Brown Medical School, 1998-2000

This course compliments the required Medical Interviewing course, running concurrently with that course. This course was developed and instituted by I in 1998 in response to student suggestions, and to expand didactic time associated with teaching medical interviewing. The seminars were revised and expanded in 1999. Two thirds of the medical school class took these seminars for credit in 1998, and one third in 1999. All first year students taking medical interviewing are invited to attend seminars. Attendance is recorded, and students not registered for the elective receive an addendum to their required Medical Interviewing course performance report documenting any voluntary participation. Course director responsibilities include: leading or co-leading several seminars, recruiting and assisting specialist faculty for seminars on a variety of topics, planning and organizing the seminar series, identifying and preparing the syllabus and related background readings, exam preparation and grading, preparing course performance reports, and course evaluation and revision.

Co-Director BI 371 - Medical Interviewing, Brown Medical School, 1993-1997

As co-director of the Medical Interviewing course, I engaged in many course directorship activities, while serving in a more secondary role in some. In particular, faculty recruitment was primarily handled by the course director and another co-director, faculty development activities were shared, and faculty and student supervision and support were shared among these three course leaders. Development and revision of the detailed student syllabus and faculty guide, however, were exclusively the responsibility of this course co-director.

Co-Director BI 372 - Human Development (Behavioral & Social Sciences), Brown Medical School, 1993-1997 This course is no longer in existence at Brown, replaced by two half-courses in psychiatry (brain and behavior) and epidemiology. At the time it was running, it was the only behavioral science course in the medical school curriculum. The course was structured to employ a combination of teaching methodologies including summary lectures, problem-based learning groups, selective seminars, and community service learning. This course co-director's main responsibility was to design and implement the problem-based leaning methodologies, and help train small group voluntary faculty. Additional responsibilities included: co-directing a selective seminar on culture and addictions, lecturing on cognitive development in childhood, and co-leading a problem-based learning group.

Educational Consultant, Affinity Group Program, Brown University School of Medicine, 1994-2002
The Affinity Group Program is a unique educational experience for students in the 8-year undergraduate/medical school program (PLME) and other students in or affiliated with the medical school programs. The goal of the program is to offer interdisciplinary experiences to students, in a self-directed small-group learning environment in order to facilitate the transition from undergraduate to medical student to physician. Groups are facilitated by voluntary faculty from a variety of backgrounds who help forward the learning process, ensure that minimum requirements are met, and provide additional resources for learning and development. This educational consultant's responsibilities in this program include: offering a faculty development program small group facilitation techniques, continuing faculty development and educational guidance offered during faculty meetings, intervention and assistance for groups experiencing problems, and consultation and assistance to program leadership on developing new educational approaches and evaluation methods.

Educational Consultant, BI 371 & 372, 1987-1993

Prior to assuming a course directorship role, I served as an educational consultant to both the Medical Interviewing course and the course in Human Development (Behavioral and Social Sciences). For both courses, responsibilities included consultation with course directors on educational direction and methodologies for these courses, and assistance in preparing instructional materials. For the Medical Interviewing course, involvement was more intense. During the initial development phase of this course, I played a key role in the organization of the course, design and documentation of teaching strategies, and the development of teaching and learning materials. The development of the Brown Interview Checklist, currently employed at multiple medical schools for medical interviewing training, was a joint effort by myself and the two course directors at the time. I drafted the first version of the student syllabus and the faculty guide, and was actively involved in educational research to validate the teaching approach employed. Over time, responsibilities expanded to include faculty supervision, faculty development, and small group teaching.

BOSTON UNIVERSITY

Small Group Faculty, Introduction to Clinical Medicine (Fall), 2008

I lead a small group of first year students in their first semester of medical school, introducing them to the clinical setting and teaching basic clinical communication skills. With no real curriculum to follow, I constructed my own, and focus heavily on providing numerous opportunities for practice in real interactions with hospitalized patients. Students in my group interview significantly more than other first year groups, and complete the semester with higher level skills including the ability to interview independently, present cases, and write a history.
