Served as Executive Director of Rhode Island KIDS COUNT from its founding in 1994 to 2022. Rhode Island KIDS COUNT is a children's policy and advocacy organization that provides data and information on child well-being, stimulates dialogue on children's issues, and promotes accountability and action with a core focus on equity. The organization provides policy makers, community leaders and the news media with the best available data and information on children's health, development, economic well-being, education, and safety. Worked with staff to create, edit and publish the annual [Rhode Island KIDS COUNT Factbook](#) (1994-2022), *Issue Briefs*, *Policy Briefs* and *Legislative Wrap-ups*. The *Factbook* provides the latest available data, trends, and policy information on 71 indicators of child well-being for the State of Rhode Island, the four core cities, and Rhode Island's 39 cities and towns. It informs data-driven advocacy across the state, with a core focus on closing unacceptable disparities by race, ethnicity, and income. Provided leadership and communications strategies for advocacy campaigns on children's public policy issues including children's health insurance coverage, childhood lead poisoning, maternal/child health, mental health, juvenile justice reform, Early Intervention, Pre-K, Head Start and Child Care, gun violence prevention, and extension of services for youth aging out of DCYF care. Regularly provided testimony on children's issues to committees of the Rhode Island General Assembly. Worked with a broad, diverse array of community leaders from all sectors on issues affecting the health, education, safety, and economic well-being of Rhode Island's children and families. Worked closely with the RI Congressional Delegation, Governor, legislative leadership, and state agency directors to identify beneficial policies and investments for children and families and to provide strategic input on their effective implementation. Planned and moderated the annual *Rhode Island KIDS COUNT Factbook Breakfasts* and *Celebration of Children's Health Luncheons*.

**As Executive Director of Rhode Island KIDS COUNT, I contributed to the following policy victories:**

- *Increase in percentage of children with health insurance coverage (from 12% uninsured in 1994 to 2% uninsured in 2022). RI is ranked best in the nation for children's health insurance coverage (tied with Massachusetts)*
- *Passage of Cover All Kids Act that restored RIte Care Coverage to all eligible children regardless of immigration status (2022)*
- *Establishment of RIte Smiles dental benefits program that provides access to oral health care for low-income children. The number of dentists accepting children with Medicaid coverage increased from 27 before RIte Smiles began in 2006 to 213 dentists in 2022*
- *Passage of RI Postpartum Coverage Extension Act- expands postpartum health insurance coverage from 60 days to 12 months for women receiving RIte Care, regardless of immigration status (2022)*
- *Passage of RI Lead Hazard Mitigation Act (2002)*

- *Reduction in childhood lead poisoning from 44% of RI children entering kindergarten with a history of elevated blood lead levels in 2005 to 4% in 2023*
- *Design, establishment, and expansion of the RI Pre-K Program, ranked number one in the nation for quality (2009-2022)*
- *Universal Full-Day Kindergarten (required by law as of 2016-2017 school year)*
- *Establishment and launch of BrightStars Quality Rating and Improvement System for Child Care (2006-2009)*
- *First permanent increase in Medicaid rates for Early Intervention Program in 20 years (2022)*
- *Supported doula/community-led effort for passage of the RI Doula Reimbursement Act, making RI the first state to require reimbursement for doula services through Medicaid and private insurance (2021).*
- *Passage of Voluntary Extension Care Act to extend DCYF services to age 21 to help ensure smooth transitions to adulthood for youth aging out of foster care (2018)*
