#### **OVERVIEW**

I am a gerontologist and health services researcher whose <u>research program</u> focuses on the pragmatic implementation and evaluation of interventions for persons living with dementia in resource-restricted, long-term care settings.

My <u>expertise</u> involves measuring neuropsychiatric symptoms and using innovative technology, such as biometric wearables and self-automated robots, to deliver interventions and evaluate stage III and IV effectiveness trials. I engage healthcare providers as partners, meaning that nursing homes or assisted living centers are not just research sites: their staff and leaders are collaborators whose perspectives inform the prioritization, design, and conduct of our research.

My <u>national reputation</u> is reflected, in part, by my roles on the IMPACT Collaboratory, a NIA training and infrastructure grant to fund and support stage IV effectiveness studies of non-drug dementia interventions. I provide expert consultation on pragmatic measurement to IMPACT funding applicants; deliver invited talks; and serve as teaching faculty for trainings.

I have demonstrated <u>scholarly independence</u> through my 50 publications published or under review (46 published; h-index of 19; 1,750+ citations) and as PI for three supplements on large, interdisciplinary and team-science efforts, considered equivalent to receipt of R01s.

I integrate <u>training and mentorship</u> into my work, engaging trainees from diverse backgrounds and propelling them into leadership roles on papers (12 in preparation or published since 2022).
