This project uses a wide range of information from 2379 girls in National Growth and Health Study, 1421 children studied in the Section on Growth and Obesity at the Eunice Shriver Kennedy National Institute of Child Health and Human Development (NICHD), and the 16,850 youth in the Growing Up Today Study to identify subgroups of children and adolescents with obesity. After these subgroups have been identified, we will then examine whether they are predictive of weight change in adolescence and young adulthood, the development of hypertension before age 35, or have a differential pattern of

association with obesity- related genes and whether the subgroups or their relationships vary by sex or race.
