Attending surgeons in the Department of Orthopedics provided the "top ten things to know" within each subspecialty, educating students on physical exam skills, diagnosis, and treatment, with an emphasis on primary care management.

Students were encouraged to ask questions pertinent to their future discipline. The elective expanded beyond future primary care physicians, including students intending to match in Plastic Surgery, General Surgery, Pediatrics, Emergency Medicine and Neurosurgery. The elective was forced to discontinue as a result of the number of students from outside the intended primary care pathway and the expansion of the Pediatric Orthopedic Surgery elective.
