The National Institute on Aging (NIA) Imbedded Pragmatic AD/ADRD Clinical Trials (IMPACT) Collaboratory works to build the nation's capacity to conduct pragmatic clinical trials of interventions embedded within health care systems for people living with dementia and their caregivers. IMPACT is the largest and most complex award received by Brown University in its sponsored research history. The award doubles the volume of research conducted at the School of Public Health and enhances the University's profile as a sector leader in Alzheimer's disease and related dementia. Under the direction of MPIs, Vincent Mor and Susan Mitchell, Administrative Core leadership is shared between Brown and Hebrew Senior Life, led by Executive Directors at each site. I serve as Executive Director for IMPACT at Brown, the prime institution and am responsible for the Grants Administration, Logistics, IRB Regulatory, and Stakeholder Engagement teams within the Administrative Core. This includes complex administrative oversight of real-time status of 30-45 clinical trials across eight system platforms that are active at any given time across IMPACT's four funding mechanisms (pilot studies, demonstration projects, health care system scholars, and career development awards). To-date there have been 11 national competitions for these funding mechanisms, resulting in 196 LOIs, 89 full applications, and 35 funded awards. In addition to administrative tracking and review of applications in the funding pipeline, I facilitate stakeholder review of full applications to the pilot grant program by people living with dementia and caregivers which informs the scientific review panel. Additional daily responsibilities include direct supervision of five staff members, including a grants & financial specialist, two project directors, and two project coordinators that work in these areas. Weekly responsibilities include meetings with MPIs, meetings with the NIA Project Officer, meetings with the grants admin, logistics, IRB regulatory teams in a weekly huddle, and individual employee check-ins. Monthly responsibilities include meetings with: MPIs, Brown grants admin and NIA Budget Office; Core Leaders, and Steering Committee. I organize twice annual meetings of the External Advisory Panel (EAP) with MPIs, NIA leadership, and the Steering committee. Annually, I am responsible for executing critical operational deliverables and timelines to the sponsor such as the writing Admin and Overall Component sections and collating the annual RPPR progress report to the NIA summarizing

IMPACT's progress and deliverables from the Administrative Core and IMPACT's 10 Cores and teams. In 2021, I facilitated the transition of IMPACT's robust funding portfolio, with more than 100 annual subawards and contracts, from a single employee model to the Research Management Support (RMS) Office at Brown. In my work, I serve as a liaison to RMS and OSP to support year end fiscal close out reports, renewal notices, and management of revised notice of grant awards for IMPACT. Additionally, I have primary responsibility for planning and organizing all aspects of the hybrid (in-person and virtual) annual business meeting and scientific conference in Bethesda, MD. This annual event brings together ~190 IMPACT researchers, awardees, faculty scholars, stakeholders, and NIA federal sponsors to discuss experiences and accomplishments within IMPACT's research community. The scientific conference includes a national call for abstracts and is livestreamed to the public via LinkedIn.

In addition to my administrative and operational role as Executive Director, I also have intellectual leadership and scholarship, with particular emphasis on stakeholder engagement. This work includes primary data collection from health care system partners for a project grant, qualitative coding and analysis of meta lessons from IMPACT pilot and demonstration projects.
