Thanks to [Governor Wes Moore's](#) brilliant leadership and courage, the State of Maryland became the first in the nation to invest \$20 million in a state-wide, community-led, place-based investment strategy that is his signature initiative. The Engaging Neighborhoods Organizations, Unions, Governments and Households Initiative ([ENOUGH](#)) is a leading strategy focused on ending child poverty and increasing economic mobility, by implementing the same model that I led in Rhode Island with the Health Equity Zones Initiative. As a result, I was honored to be recruited as the Senior Advisor for Strategy to serve as the Strategic Lead to help successfully build out and launch the ENOUGH Initiative. Fulfilling the focus of the National Investment in CommunitiEs (NICE) infrastructure I have envisioned, my role with the State has served to help build the science for braiding public-private investments that are distributed to strengthen the infrastructure of communities previously overlooked. Through this implementation roadmap being applied in the Maryland state leadership environment, this focus on investing in communities also sustains the impact by changing how governing and braiding of steady-state resources can work to be leveraged by state leadership nationwide.

I served in leading roles on two major projects with the National Foundation for the Centers for Disease Control and Prevention (CDC Foundation) that focus on implementation of strengthened community infrastructures through direct investment of resources at the community level. The first project consists of the next level of incubation to create the infrastructure that I have envisioned to serve as a roadmap for state leadership teams across the country, the National Investment in CommunitiEs (NICE). This initiative aims to create a national culture of healthy communities strengthened through community-level investments by creating implementation roadmaps for state leadership to adapt in their environments. This initiative focuses on building the science of braiding funding streams that will sustain public-private investments in communities. The People and Places Thriving Initiative led by Health and Human Services has sought ways to implement at the state level its focus on leveraging funds from over 40 federal agencies that are directed towards strengthening communities. Through NICE, already with support from the CDC Foundation and the Association of State and Territorial Health Officials (ASTHO), state leadership throughout the country can receive implementation guidance to facilitate braiding of available funds that better support and sustain community civic infrastructures for driving transformative action.

The second major project is another level of implementation that aligns with the focus of NICE. Recognizing the importance of resources being invested in strengthened community infrastructures, the CDC Foundation is leveraging my expertise to co-develop and test strategies with core members of a minimum community partnership triad: community leaders, governmental public health leaders, and healthcare system leaders. As Senior Executive Consultant, I help lead the planning and implementation for multiple core triads throughout the country to create a roadmap for strengthening multisector partnerships that will benefit community needs. The outcomes are intended to inform the national models for building the science on sustaining investments and strengthened infrastructure in communities that will drive lasting upstream change.

As President of the Board at ASTHO in 2018-2019, I led the challenge Building Healthy and Resilient Communities. ASTHO's Board has since decided not to change to the next President's challenge the following term, but has extended and now embedded that focus into the organization permanently as the [ASTHO Challenge](#). Joining the team as a Senior Executive Consultant, who worked closely with the CEO and current Senior VPs, I am leading the creation of an innovative infrastructure, National Investment in CommunitiEs (NICE). This center of expertise will be a resource hub specifically catered for state, territorial, county, and local governments and public health agencies to effectively invest in communities using evidence-based, place-bed, community-led interventions. The goal will be to ensure that the previous focus on and funding of health equity initiatives throughout the country will most effectively benefit the historically disadvantaged communities that must transcend and reshape systems and policies in place to bounce forward as healthy and resilient communities. Leveraging this focus to sustain those investments long-term is the key for NICE.

In addition to this major focus on NICE, I have contributed to a number of projects throughout ASTHO that serve to reinforce the implementation of state leadership understanding how to drive

investments of steady-state public and private resources into communities for sustained transformation. Several of my leading roles have centered on executive coaching of state leaders to build their knowledge and application of current experiences to influence change at every level for better conditions in their state's communities. As a result, I have contributed to state leaders throughout the country better implementing their approach to focusing resources towards previously disinvested in communities, while navigating their political and funding environments.

I was invited to be a guest editor for the supplemental issue of the American Journal of Public Health (AJPH) that captures the nationwide lessons learned of caring for the most vulnerable populations, particularly during COVID. Titled "Reducing COVID-19 Disparities," this entire AJPH supplement is focused on the Centers for Disease Control and Prevention OT21-2103 grant recipients' novel and emerging best practices to reduce COVID-19 health disparities among racial/ethnic populations, rural communities, and other populations experiencing inequitable outcomes as a result of mobilizing community partnerships, building infrastructure support, improving data collection/reporting, and disease mitigation with prevention efforts. I have been able to lift up the importance of investing in communities historically disinvested in to change the future trajectory of disparate outcomes in future challenges such as pandemics or everyday adversities. infectious disease subspecialist, a Governor-appointed state health official for almost seven years, including leading the State through the COVID-19 pandemic, and a previous ASTHO president focused on building healthy and resilient communities.

As the Director of Health for RI, I served as the public health face of the COVID-19 response since the first case of coronavirus was identified by the RIDOH State Health Laboratories. Reporting to the public at the initially daily press conferences, messaging the dynamics of the science as it evolved, engaging with the Governor's Whole of Government leadership across the entire response, and leading the public health agency that expanded significantly in size and budget were among the many examples of qualifications required to guide Rhode Island successfully through the COVID-19 pandemic. At a minimum the budget overseen exponentially increased by \$500 million to address the core public health elements of the response, but public health touched some element of the full \$1.83 billion awarded to Rhode Island for the first package of COVID relief. I consistently worked more than 100+ hour weeks.

The Rhode Island Department of Health (RIDOH) is a state agency in Rhode Island with over 470 employees currently and a budget of up to \$170 million. Connected with the three other state agencies within the Rhode Island Executive Office of Health and Human Services (EOHHS), RIDOH is a sister agency to the Departments of Children, Youth, and Family Services; Human Services; and Behavioral Healthcare Developmental Disabilities, and Hospitals. The RIDOH Director position is appointed by the Governor, as a Cabinet member, and confirmed by the Senate.

After becoming Director in April 2015, I established three leading priorities for the Department (address social and environmental determinants of health; eliminate health disparities and promote health equity; and ensure access to quality health services for all Rhode Islanders, including our vulnerable population). During my time in service as Director, these RIDOH leading priorities have been the foundation for forming five strategies and twenty-three respective population health goals shared across EOHHS and on behalf of Rhode Island. Of greatest importance, the implementation of these leading priorities were demonstrated strongest through leading the **Rhode Island Health Equity Zones Initiative**. This has served as the nation's first statewide, community-led, place-based investment strategy that braided federal, state, and philanthropic resources to support strengthening community infrastructures. Since this launch there have been subsequent similar statewide initiatives in Washington and most recently in Maryland, which is the first mirrored statewide, community-led investment strategy to be led by a Governor.

As part of the organizational restructuring that I led at the Department, I created the RIDOH Academic Institute to strengthen the integration of scholarly activities with public health practice, by instilling a culture of learning and innovative implementation, via continuous quality improvement. Through my leadership, the RIDOH Academic Institute's external-facing core program has focused on innovative problem solving by engaging with academic partners throughout the state: Public Health Education and Research Program. Academic institutions of higher education across Rhode Island have established formalized agreements signed by the respective President and by me as the Director of RIDOH, such that all students and faculty would engage in scholarly activities with the Department through enhanced public health learning and research experiences. The internal facing arm of the RIDOH Academic Institute focused on Workforce and Career Development to advance the skillsets and expertise of the public health workforce.

With my vision as the Director of RIDOH, the RIDOH Academic Institute has begun developing research education tracks for students, residents, and fellows. The first is a combined Pediatric Infectious Diseases and Pediatric Pharmacy Fellowship Track in Public Health that establishes a partnership with RIDOH, the Division of Pediatric Infectious Diseases at Hasbro Children's Hospital, and the Doctor of Pharmacy Program at the University of Rhode Island. Pediatric Infectious Disease and PharmD fellows were intended to have formalized research educational experiences at the RIDOH, particularly with the Division of Preparedness, Response, Infectious Disease and Emergency Medical Services. In addition to fulfilling this major teaching role through my visionary leadership of the RIDOH Academic Institute, I have also advanced my research career by partnering with academic faculty at Brown University to apply for R01 National Institutes of Health grants that support applied practice public health and implementation science. Two such research proposals that will benefit the Department, thus far involve HIV and opioid overdose prevention and intervention. The HIV phylogenetics R01 NIH grant has been awarded as of March 2018, and after successful implementation, renewal has been submitted in 2023.

The ASTHO Board of Directors is the organization's administrative body. The President is elected by the ASTHO Assembly of Members, which is composed of the entire voting membership of ASTHO and is the organization's policy formulating body. This voting membership for ASTHO includes the chief health officials for each U.S. state and territory, as

well as the District of Columbia. Traditionally, the Assembly of Members meets in formal session once a year at the ASTHO Annual Meeting. The Board of Directors is comprised of the officers of the Association (president, president-elect, immediate past president, past president, and secretary-treasurer), ten regional directors, two territorial directors, the chairs of the Senior Deputies Committee and Affiliate Council, and one Alumni Society representative. The ASTHO Board of Directors meets formally on a quarterly basis.

Each year historically, the ASTHO President selects a President's Challenge that the nation's public health community and fellow state and territorial health officials are asked to embrace and shape their public health programs to respond to. For my term, the President's Challenge I led was "Building Healthy and Resilient Communities" by supporting diverse investments in community-led, place-based approaches. The Surgeon General, and his priority focusing on Community Health and Economic Prosperity, along with the National Association of County and City Health Officials responded to invitations to be leaders with the President's Challenge along with ASTHO. This focus was so favorably received that each subsequent President continued the Challenge and the ASTHO Board of Directors with support from the Assembly of Members voted to adopt my President's Challenge as the [ASTHO Challenge: Building Healthy and Resilient Communities](#), which continued for several subsequent years.
