COMMITMENT TO DIVERSITY, EQUITY, INCLUSION, JUSTICE & ANTI-RACISM

I am demonstrating my commitment to these principles through mentorship in the BRIDGE program, various teaching activities, academic publishing and grant preparation. In 2023, I was asked to chair the Association of Behavioral and Cognitive Therapist Dissemination and Implementation Science Special Interest Group preconference committee. Collaborating with 4 NIMH-funded ALACRITY centers across the United States, I developed the theme of this 4-hour, interactive workshop around how to make implementation methods more equitable – highlighting methods that (1) centered around giving individuals equity in the implementation process and (2) focused on achieving equitable implementation outcomes. I have given several other talks related to equity in implementation and intersectionality in clinical practice in national venues and in our BRIDGE program. I am currently developing a new 2.5-day Bootcamp focused on implementation methods, centering equity through intersectionality and reflexivity; I was selected as a 2024 Brown Advocate for Social Change and Equity Fellow to develop this Bootcamp with these themes at the center. Finally, I am developing research activities focused upon equity and anti-racism, including several R01 grant proposals seeking to

achieve more equitable outcomes in suicide prevention in Puerto Rico and justice-involved youth in the United States. As my research program grows, I will continue to evolve in my own understanding of these principles through a culturally humble, reflexive, and intersectionally-minded approach.
