Narrative Report

I have been conducting research in the assessment and treatment of suicidal behaviors for over 20 years. I have built a programmatic line of research in two main areas: 1) the longitudinal development of borderline personality disorder and bipolar disorder; 2) the assessment and treatment of suicidal behaviors in populations with severe mental illness. I have received continuous grant support from NIH for the past 20 years, including being a PI of 7 NIH grants and 3 private foundation grants, and have authored/co-authored 119 peer-reviewed research manuscripts. I continue to be committed to clinical research that has direct relevance to treatment to alleviate the suffering of those with severe mental illness.

Area of Excellence: Investigation

Early in my career, I was fortunate to be part of the Collaborative Longitudinal Study of Personality Disorders (CLPS). My specific contribution was in the area of suicidal behaviors. I first-authored a number of papers from CLPS (Yen 2003, 2005) that examined risk factors as both static (distal) and dynamic (proximal) variables which was a novel concept then. Now, the importance of both distal and proximal risk factors in predicting suicidal behaviors is widely recognized. Collectively, CLPS yielded a number of findings that have greatly influenced our present thinking on personality disorders. We found that many people with personality disorder do remit from their disorders, and this finding, which has been corroborated by research from other longitudinal studies, has provided great hope and optimism for those who suffer from personality disorders. However, we also found that despite diagnostic remission, functional impairment often remains, highlighting the need to target functioning in psychotherapy. Finally, our findings with regard to the superiority of a hybrid model for conceptualizing personality disorders was highly instrumental in the DSM-5's inclusion of Section 3.

I have also been an MPI on a multi-site longitudinal study of bipolar disorders, the NIH-funded Course and Outcome of Bipolar Youth (COBY), later continuing as Predicting Adult Outcome of Bipolar Youth. My main contributions in this study have been in the areas of examining the complex interplay between bipolar disorder (BP) and borderline personality disorder (BPD), and in examining longitudinal effects of comorbidity and functioning. We found that BPD severity adds significantly to the burden of BP illness and is significantly associated with a more chronic and severe course and outcome of BP, beyond characteristics such as BP subtype (I, II, NOS) and age of onset (Yen et al., 2015). Coupled with earlier findings from CLPS supporting independence in the course of illness of BPD and BP (Gunderson et al., 2006), my work supports the distinction of these as independent disorders with overlapping symptoms. We have also examined the effect of Axis I comorbidity on the course of mood symptoms and have found support for depression and anxiety as manifestations of the same illness propensity, an effect was not observed with other disorder groups, indicating the specificity of this association (Yen et al., 2015). I am currently taking the lead on a series of examinations, regarding longitudinal functioning in COBY and have found that significant functional impairments remain in bipolar young adults despite symptomatic remission in a sizable subgroup (Hower et al., 2019, Lee et al., 2020). I am currently working with mentees on additional manuscripts to further explicate the nature of functional impairment in this sample.

Another area of investigation has been in the development of interventions for suicidal behaviors in adolescents and young adults. My career development award found that low positive affect was a robust predictor of suicidal behavior over six months of post-discharge follow-up (Yen et al., 2012).

This led me to develop a multi-modal (in-person + text messaging) positive affect skills intervention (Skills to Enhance Positivity; STEP) that resulted in 50% fewer suicide events, when compared to those in the comparison condition (Yen et al., 2020). Due to the initial promising results, some aspects of STEP have been implemented outside of sponsored research projects. STEP groups were implemented in a college counseling service, and components of STEP were integrated into a suicide prevention app, a product of a joint venture between academic research and software developers, funded by a benefactor. Future goals include testing STEP in a large multi-site R01 (under review) and novel and cost-effective means of dissemination including groups, peer support, and via video content.

<u>Significant Supporting Activities</u>: Teaching and Educational Contributions and Administrative and Institutional Service

Throughout my career, I have been committed to teaching and mentorship of individuals at varying levels of training -- from Brown University undergraduates seeking mentorship on honors theses, to post-BA research assistants aspiring to gain admission to a clinical psychology program, to clinical psychology interns and psychology post-doctoral fellows. I have taught seminars, served as a course coordinator, and have provided research and clinical supervision to interns and post-doctoral fellows. I am currently the primary mentor on a K23, co-mentor on another, and primary mentor on an AFSP grant. I have fostered the professional development of many mentees who now hold academic positions at many highly esteemed institutions.
